ORDER

In order to streamline the admission procedure in the Demonstration Multipurpose (DM) Schools in the Regional Institutes of Education, N.C.E.R.T., the following admission policy comes into force with immediate effect. This order is in supersession of all previous orders, circulars, letters and minutes of meetings related to D.M. School admission issued by the Council from time to time.

I. Admissions into Class-I

1. A Committee consisting of three teachers from the Primary Section School with I/c Primary section as its Chairperson will process the applications.
2. Reservations in admission for the wards of eligible categories will be as follows:

i) Scheduled Caste	15%
ii) Scheduled Tribe	7%
iii) Physically Handicapped	1%
iv) Ex-Servicemen	2%
v) NCERT regular Employees	24%
vi) General	50%

3. Pattern followed in Kendriya Vidyalayas for determining the eligibility criteria of age will be strictly followed henceforth. Applications will be processed with reference to reservations quota after scrutiny of certificates submitted in support of age and reservations etc.

Data will be entered and computerised eligibility lists will be notified. Corrections will be carefully made for the computerised random selection.

5. On the date notified by the Committee, selection lists for various categories will be generated by computer generated random numbers in the Computer Centre of the RIE. This will be carried out in the presence of the members of Admission Committee and a few parent-representatives.

6. The Admission Committee will consist of the following:

- i) Dean of Instructions, Chairman
- ii) I/c Head, Primary Section, D.M. School (Member-Convenor)
- iii) One faculty member of the D.M. School
- iv) Headmaster, D.M. School
